SPECIAL ARRANGEMENTS FOR SPECIAL GENERAL MEETING TO BE HELD ON 1 MARCH 2022

In light of the current COVID-19 epidemic situation, the SGM to be held on 1 March 2022 (Tuesday) will be conducted by electronic means through a live webcast, and no physical attendance is accepted.

Reference is made to the circular of Emperor International Holdings Limited (the "Company") dated 26 January 2022 ("Circular") setting out, inter alia, the notice of Special General Meeting of the Company to be held on 1 March 2022 ("SGM"). Capitalized terms used herein shall have the same meanings as defined in the Circular unless the context otherwise requires.

Attending the SGM by Electronic Means

Shareholders, proxies or corporate representatives may attend virtual SGM by electronic means through a live webcast whereby they can cast their votes and submit questions online, and no physical attendance is accepted.

Login details for registered Shareholders

Relevant information including login details to access the online platforms shall be included in a separate e-Meeting notification letter to be sent by the Company's Share Registrar to each registered Shareholder who may access the e-Meeting system platform ("Online Platform") for attending the SGM online by a computer, tablet or any browser enabled device.

Login details for non-registered Shareholders

Non-registered Shareholders who wish to attend and participate in the SGM through the Online Platform should (1) contact and instruct their banks, brokers, custodians, nominees or HKSCC Nominees Limited (together the "Intermediary") (through which the shares of the Company are held on their behalves) to appoint themselves as proxies to attend the SGM; and (2) provide their e-mail addresses to their Intermediary before the time limit required by the relevant Intermediary.
