For this purpose, seniority will be determined by the order in which the names stand in the register of members of the Company.

To be valid, this form of proxy, together with any power of attorney or other authority (if any), which it is signed or a certified copy thereof, must be deposited at the Company's Hong Kong branch share registrar, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for holding the SGM or any adjournment thereof.
- 9. Completion and return of the form of proxy will not preclude you from attending and voting in person at the SGM or any adjournment thereof if you so wish. In such event, this form of proxy will be deemed to have been revoked.

PERSONAL INFORMATION COLLECTION STATEMENT

- 4. You have the right to request access to and/or correction of your Personal Data in accordance with the provisions of the PDPO.
